OUR PARTNER AGENCIES OPERATE FOOD ASSISTANCE PROGRAMS IN CULVER CITY, INGLEWOOD, THE LAX AREA, MALIBU, SANTA MONICA, VENICE, WEST LOS ANGELES, AND WEST HOLLYWOOD.

DURING THE FISCAL YEAR JULY 1, 2022 - JUNE 30, 2023, WESTSIDE FOOD BANK DISTRIBUTED 4,991,802 POUNDS OF NUTRITIOUS FOOD, MORE THAN DOUBLE THE AMOUNT DISTRIBUTED PRIOR TO THE PANDEMIC. 67% OF THE FOOD DISTRIBUTED WAS FRESH PRODUCE, HIGH PROTEIN FOODS AND DAIRY PRODUCTS AND LESS THAN 2% WAS HIGH SUGAR OR SALT SNACK FOODS. WE ENDED A SHORT TERM LEASE ON 10,000 SQUARE FOOT WAREHOUSE AND ENTERED INTO A 2 YEAR LEASE ON A
